Guests to a Mesquite High School dance/event must abide by the following regulations:

- Must be a high school student or under the age of 21. **Please attach a copy of one of the following: 1) Guest's Student Id if a high school student or 2) Guest's Driver's License if not in high school for proof of age.**
- If guest is a high school student this form must be signed by their high school Administrator and the Administrator must attach a copy of their business card.
- **Guests must show his/her driver's license or current high school ID for admission to the dance/event.**
- MHS students are responsible for the behavior and demeanor of their guests. MHS students are responsible for informing their guests of all MHS behavior and dress code rules. In the event that a guest does not follow the rules, he/she will not be allowed to attend another MHS event requiring a guest pass.
- The following are specifically prohibited at MHS school sponsored dances: Sexually explicit dancing (i.e. freaking, grinding or dirty dancing) and any dancing that may result in disruption or injury (i.e. slamming, moshing, etc.).
- Any person removed from the dance by MHS school staff is not entitled to a refund.

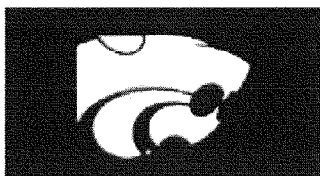

All MHS students must present a MHS ID card to be admitted to this event. All guests must have a current school ID or other photo ID and an approved contract on file.

All students and guests must abide by the following regulations:

1. All school rules apply at school sponsored events for both students and guests. Violations may result in disciplinary action and/or removal from the activity.
2. Students and guests under the influence of drugs, alcohol or any controlled substance will be denied entrance to the activity and are subject to disciplinary action. Students are expected to abide by the following dress code:
 - a. Dresses should not be shorter than mid thigh, and slits must not be higher than mid thigh.
 - b. No see-through clothing.
 - c. No exposed midriffs or cleavage.
 - d. Neck line must not be lower than bust line.
 - e. Shirts must remain on and "low riders" or "sagging" pants are not permitted.
3. Mesquite High is not responsible for lost or stolen items.
4. Dancing must be appropriate. No sexually explicit dancing. (i.e. freaking, grinding, or dirty dancing). No dancing which may result in disruption or injury (i.e. slamming or moshing).
5. Tickets may not be transferred to another student.
6. No re-entry is allowed. If you leave the activity for any reason, you may not return.
7. Tickets to events including dances are non-refundable.
8. Event participants will conduct themselves as ladies and gentlemen.
