## Playa del Rey: Title I Family & Community Engagement Policy

## **Statement of Purpose:**

At Playa del Rey, we believe that the engagement of families and community members is an essential component of nurturing students. Every effort to invite and consider family and community input should be made to ensure the success of our students. A team of parents, teachers, and administrators developed the following family/community engagement plan.

Based on a needs assessment the following strategies were outlined:

- I. Playa del Rey Elementary's Family/Community Engagement Policy and Compact is distributed to parents by mail and in backpacks as new students enter the Title I program. School involvement opportunities and curriculum are communicated during:
  - A. Open House Held prior to school opening. This is an opportunity for families and students to meet their teacher, see their classrooms and learn of involvement opportunities.
  - B. Family Engagement/Curriculum Event Usually held in the beginning of each school year. Because of continuing COVID restrictions and guidelines, our event was held virtually. A screencastify was created and shared with families. Families received information on the curriculum that will be used in the classroom, Playa del Rey's Title I status, how students are ranked based on their academic needs, and what research-based intervention programs will be used (ex. Lexia and iReady). Contact information was given so parents could ask questions about the programs and/or their child's involvement in them.
  - C. Parent-Teacher Conferences Held once a year at the end of the first grading period. Parents/families are invited to meet with their classroom teacher and Title I specialist to discuss, in a private parent-teacher conference, how the student is doing in school, their strengths, their weaknesses, and how the school and parents can help the student succeed. This is one of the times that student progress and assessments are shared with parents.
  - D. Student/Parent Handbook The district Student/Parent Handbook is available online on the district's website (This publication is available in both English and Spanish.)
- II. Family and Community Members were/are engaged in the development of the Title I, Part A planning process of the school review and improvement in the following ways:
  - A. Feedback provided from families in the form of a written/online survey.
  - B. An on-campus operating School Council supports the Title I program.
  - C. Family/Community Members are asked to serve on committees as needed.
- III. Build the school's and families' capacity for strong Family Engagement in the community.
  - A. The district's website provides information on the policy manual, district news and community news.
  - B. Monthly school newsletters are produced and distributed by the principal.
  - C. Family learning opportunities such as Scholastic Book Fairs, literacy and math nights.
- IV. Opportunities for family/community engagement will be integrated/coordinated with the other programs such as ELL, Special Education, Social Services, and other school programs.
- V. An evaluation process of family/community engagement will be conducted at the end of each school year. The evaluation will specifically look at barriers to family/community engagement and develop strategies to increase involvement of all population segments. The evaluation will be composed of:
  - A. Family/community surveys
  - B. Representatives reporting to the leadership cabinet.
- VI. Information Gathered from the evaluation will be used in:
  - A. Planning next school year's Title I program.
  - B. Developing targeted strategies to increase family/community engagement.
  - C. Revising school policy/procedures as needed.
